**Facility Description:** Applicant applied to the New York State Office of Renewable Energy Siting and Electric Transmission (Office or ORES) for a permit pursuant to Public Service Law article VIII to construct and operate a 135-megawatt (MW) solar energy facility located in the Towns of Leicester and York, Livingston County.

Prior Combined Notice of Availability of Draft Permit Conditions, Public Comment Period and Public Comment Hearing, and Commencement of Issues Determination Procedure:

Applicant filed the application with the Office on December 7, 2023. A notice of complete application was issued on July 15, 2024 (see <a href="https://dps.ny.gov/ores-permit-applications">https://dps.ny.gov/ores-permit-applications</a>, click on Project Permit Application Number 23-00059).

ORES staff published draft permit conditions on September 13, 2024. The draft permit conditions may be accessed at <a href="https://dps.ny.gov/ores-permit-applications">https://dps.ny.gov/ores-permit-applications</a>, click on Project Permit Application Number 23-00059.

On September 13, 2024, the ORES Office of Hearings issued a combined notice of availability of draft permit conditions, public comment period and public comment hearing, and commencement of issues determination procedure (Combined Notice). The Combined Notice scheduled a public comment hearing pursuant to 16 NYCRR part 1100 to hear and receive

unsworn comments from the public at the York Town Hall, 2668 Main St, York, NY 14592, on Wednesday, November 13, 2024, at 6:00 p.m. The Combined Notice also established a deadline of Friday, November 15, 2024, for the filing of written public comments and other deadlines for the issues determination procedure. <u>Notice of Additional Public Comment Hearing</u>: PLEASE TAKE NOTICE THAT pursuant to this Notice of Additional Public Comment Hearing, a second public comment hearing pursuant to 16 NYCRR part 1100 to hear and receive unsworn comments from the public will be held virtually on Tuesday, December 10, 2024, at 6:00 p.m. The hearing is being conducted through the Webex electronic webinar platform and by telephone.

All persons, organizations, corporations, or government agencies who may be affected by the facility are invited to attend the hearing and comment on the application and the draft permit conditions. **Instructions on how to register for and attend the Webex webinar are provided below.** Lengthy comments will not be accepted and instead should be submitted in writing. Equal weight will be given to both oral and written comments. To ensure that all interested persons have an opportunity to speak, the Administrative Law Judges (ALJs) may limit the time available for oral comments to three (3) minutes per person. The public comment hearing will be transcribed for inclusion in the administrative record.

It is not necessary to provide comments at both the November 13 and the December 10 hearings. At the December 10 hearing, preference will be given to speakers who did not speak at the November 13 hearing.

Interpreter services shall be made available to deaf persons, and English language translator services shall also be made available, at no charge for either service, upon written request to Chief ALJ James T. Persons wishing to comment on the application or the draft permit conditions will have the opportunity to make a statement at the public comment hearing. Any person wishing to provide a public statement must register in advance of the hearing no later than 10:00 a.m.

Monday, December 9, 2024. Any person who wants only to observe the hearing online must also pre-register. Any person may listen to the hearing by phone without pre-registration.
